Labor Category Descriptions

SUBJECT MATTER EXPERT

Duties: Provides technical leadership, direction, and special skills for complex tasks and portions of tasks that require unique or uncommon levels of expertise related to specific functional subject matter. Ensures that work within area of responsibility is complete, meets customer requirements, and is of high quality.

Qualifications: A Subject Matter Expert is a highly skilled individual who has acknowledged unique or uncommon technology and/or functional expertise in specific areas that are essential for the performance of a particular task. Such individuals should possess capabilities that are not available under other labor categories. Four years unique or specialized experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline plus ten (10) years of related experience; or Masters degree in related discipline plus twelve (12) years of related experience; or Bachelors degree in related discipline plus fifteen (15) years related experience.

Skill Level 2 - Doctorate degree in related discipline plus five (5) years of related experience; or Masters degree in related discipline plus eight (8) years of related experience; or Bachelors degree in related discipline plus ten (10) years related experience.

PROGRAM MANAGER

Duties: Serves as manager for contract or major project/task. Performs overall program planning for technical and contractual efforts. Responsible for formulating and enforcing work standards, assigning contract schedules, and the review of the work discrepancies. Supervises personnel, communicates policies, purposes, and goals of the organization to subordinates. Responsible for the management of the entire project and assigned staff. Responsible for the overall contract performance including quality control practices and procedures.

Qualifications: Personnel in this category must have earned a degree in engineering, science or program management disciplines from an accredited college or university. Experience is required in performing hands-on weapon-system and/or aerospace systems research and development. Additional experience must have been in a technical management role, which includes performing functions such as initiating, evaluating, redirecting, and approving large and highly complex research and development programs and making resource allocation decisions. Four years unique or specialized experience may be substituted for a degree.



Skill Level 1 – Doctorate degree in related discipline plus eight (8) years of related experience; or Masters degree in related discipline plus ten (10) years of related experience; or Bachelors degree in related discipline plus twelve (12) years related experience, or sixteen (16) years of related experience of which ten (10) years must have been in a management role.

Skill Level 2 –Doctorate degree in related discipline plus four (4) years of related experience; or Masters degree in related discipline plus eight (8) years of related experience; or Bachelors degree in related discipline plus ten (10) years experience, of which four (4) years must have been in a management role.

Skill Level 3 - Doctorate degree in related discipline; or Masters degree in related discipline plus six (6) years of related experience; or Bachelors degree in related discipline plus eight (8) years related experience, of which two (2) years must have been in a management role.

ENGINEER/SCIENTIST

Duties: Performs and plans research, design development other assignment in conformance with design, engineering and customer specifications. Implements technical solutions in appropriate scientific techniques, concepts, methods, tools and/or development of complex software application programs. Designs or prototypes missile system or subsystems hardware/software, or designs and conducts tests or analyzes the resulting test data. Develops or validates, or modifies models or simulations or analyzes the resulting simulation data, all using a higher order electronic language and a variety of peripheral high resolution graphic devices.

Qualifications: Personnel in this category must have earned a degree in engineering, science or related disciplines from an accredited college or university. Experience is required in performing hands-on weapon-system and/or aerospace systems research and development. Four years unique or specialized experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline plus six (6) years of related experience; or Masters degree in related discipline plus ten (10) years of related experience; or Bachelors degree in related discipline plus twelve (12) years related experience.

Skill Level 2 – Doctorate degree in related discipline plus two (2) years of related experience; or Masters degree in related discipline plus six (6) years of related experience; or Bachelors degree in related discipline plus eight (8) years related experience.

Skill Level 3 – Doctorate degree in related discipline; or Masters degree in related discipline plus three (3) years of related experience; or Bachelors degree in related discipline plus six (6) years related experience.

Skill Level 4 – Masters degree in related discipline or Bachelors degree in related discipline plus two (2) years related experience.



Skill Level 5 – Bachelors degree in related discipline.

Skill Level 6 – Presently enrolled as a student in an accredited Bachelor's or Associate's degree program.

TECHNICAL SPECIALIST/ANALYST/PROGRAMMER

Duties: Works independently applying analytical and systematic approaches to problem solving. Uses fundamental principles, techniques and practices with guidance from senior level managers.

Qualifications: Requires experience in appropriate engineering/scientific techniques, concepts, methods, and tools and/or development of software application programs.

Skill Level 1 – Presently enrolled as a student in a Bachelor's or Associate's degree program or high school diploma (or equivalent) plus eight (8) years related experience.

Skill Level 2 – High School Diploma (or equivalent) plus six (6) years related experience.

LEGAL ADVISOR

Duties: Provides legal consultation in the areas of military, civil and international law as it applies to technology, operations, program plans and execution. In addition the expert will provide consultation to senior program leaders and international partners.

Qualifications: Personnel must be U.S. attorneys admitted to the Bar in any U.S. State or territory and will focus on the specific legal requirements of the program, the region, and the applicable regional military, civil, and international law.

Skill Level 1 – Doctorate degree in related discipline plus three (3) years of related experience, or Master's degree in related discipline plus five (5) years of related experience, or Bachelor's degree in related discipline plus eight (8) years of related experience.

Skill Level 2 – Doctorate degree in related discipline, or Master's Degree in related discipline plus three (3) years of related experience, or Bachelor's degree in related discipline plus five (5) years of related experience.

Skill Level 3 – Master's degree in related discipline, or Bachelor's degree in related discipline plus two (2) years of related experience.



TECHNOLOGY/ANALYTICAL SPECIALIST

Duties: Evaluates specialty or All-Source Analysis using OSINT, SIGINT, HUMINT and or IMINT as it relates to threat and vulnerability analysis relevant to the program. The analyst provides operational evaluation and analysis of government unique and/or Commercial-Off-The-Shelf (COTS) technology related to collecting, tagging, tracking, locating, signal intercepts, data processing, HUMINT interactions and surveillance. Analyzes and develops data products/reports related to the above activities.

Qualifications: Personnel will be experienced in investigative intelligence using physical and/or electronic means of collecting data. Must be proficient in analyzing and validating data to ensure accuracy. Must have prior relevant tactical and/or intelligence operations experience. Experience in one of the following disciplines is required: HUMINT, SIGINT, IMINT or OSINT. Four years of related experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline plus three (3) years of related experience, or Master’s degree in related discipline plus five (5) years of related experience, or Bachelor’s degree in related discipline plus eight (8) years of related experience.

Skill Level 2 – Doctorate degree in related discipline, or Master’s degree in related discipline plus three (3) years of related experience, or Bachelor’s degree in related discipline plus five (5) years of related experience.

Skill Level 3 – Master’s degree in related discipline, or Bachelor’s degree in related discipline plus two (2) years of related experience.

RECONNAISSANCE & SURVEILLANCE (R&S) SPECIALIST

Duties: Provides comprehensive operational evaluation and analysis of reconnaissance and surveillance systems, to include products and associated interpretation and analysis systems.

Qualifications: Personnel will be experienced with the U.S. Military or a U.S. National agency. Prior relevant tactical and/or intelligence operations experience is essential. Four years of related experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline, or Master’s degree in related discipline plus ten (10) years of related experience, or Bachelor’s degree in related discipline plus twelve (12) years of related experience.



Skill Level 2 – Doctorate degree in related discipline, or Master’s degree in related discipline plus eight (8) years of related experience, or Bachelor’s degree in related discipline plus ten (10) years of related experience.

Skill Level 3 – Master’s degree in related discipline or Bachelor’s degree in related discipline plus eight (8) years of related experience.

Skill Level 4 – Bachelor’s degree in related discipline plus five (5) years of related experience.

Skill Level 5 – Bachelor’s degree in related discipline plus three (3) years of related experience.

TECHNICAL TRANSLATOR

Duties: Provides comprehensive translation of program technical and operational material to include using correct syntax and expression from and to the target language. Individuals must possess the ability to conduct accurate translation/interpretation to include the ability to maintain the integrity and meaning of translated material. Individuals will possess the ability to document activities in written reports.

Qualifications: Personnel must have native proficiency in target language(s). A degree in language and/or communication skills is a plus. Four years of related experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline plus three (3) years of related experience, or Master’s degree in related discipline plus five (5) years of related experience, or Bachelor’s degree in related discipline plus eight (8) years of related experience.

Skill Level 2 – Doctorate degree in related discipline, or Master’s degree in related discipline plus three (3) years of related experience, or Bachelor’s degree in related discipline plus five (5) years of related experience.

Skill Level 3 – Master’s degree in related discipline, or Bachelor’s degree in related discipline plus two (2) years of related experience.

COMMUNICATIONS SPECIALIST

Duties: Provides expertise in operational evaluation and analysis of Automatic Data Processing (ADP) and communications systems. Analyzes and integrates radio frequency, landline and SATCOM communications into a coherent system.



Qualifications: Personnel will have experience with classified data communications support. Prior relevant tactical and/or intelligence operations experience is essential. Four years of related experience may be substituted for a degree.

Skill Level 1 – Doctorate degree in related discipline or Master’s degree in related discipline plus three (3) years of related experience, or Bachelor’s degree in related discipline plus eight (8) years of related experience.

Skill Level 2 – Bachelor’s degree in related discipline plus four (4) years of related experience, or minimum of eight (8) years experience obtained with military, law enforcement or intelligence services related arenas.

Skill Level 3 – Minimum of six (6) years of related experience obtained with military, law enforcement or intelligence services related arenas.

PRINCIPAL INVESTIGATOR

Duties: Provides complex technical and operational evaluation and analysis of intelligence and law enforcement investigative systems relating to: narcotics, Racketeer Influenced and Corrupt Organizations (RICO), High Intensity Drug Trafficking Area (HIDTA), confidential source management, international crime, and financial crime. Serves as a technical subject matter expert supporting federal, state and/or local agencies.

Qualifications: Personnel require diverse backgrounds and varied federal, state, and local law enforcement experience. Direct liaison experience between Law Enforcement elements is a plus. Law Enforcement professionals will be required to have active law enforcement experience including a minimum of 4 years of complex investigative work experience. Experience with technical collections equipment and processes is a plus. Four years of related experience may be substituted for a degree.

Skill Level 1 – Master’s degree in related discipline plus twelve (12) years of related experience, or Bachelor’s degree in related discipline plus twenty (20) years of related experience.

Skill Level 2 – Master’s degree in related discipline plus eight (8) years of related experience, or Bachelor’s degree in related discipline plus twelve (12) years of related experience.

Skill Level 3 – Bachelor’s degree in related discipline plus eight (8) years of related experience.

Skill Level 4 – Bachelor’s degree in related discipline plus six (6) years of related experience.

Skill Level 5 – High School diploma (or equivalent) plus four (4) years of related experience.



RESEARCH ENGINEER/SCIENTIST

Duties: Plans and conducts testing on an assigned project to prove or modify theoretical propositions on the basis of comments in the literature field, established research findings, and the experience of other staff members in the technological area. Interacts with other research staff. Discusses progress and interim findings at monthly technical review meetings. Continues with project in original concept or modifies direction based on commentary and decision of technical review committee. Sets up prototype equipment and uses experimental materials to test theories developed. Works with customer line and technical personnel to test out theories and/or findings.

Qualifications: Personnel must demonstrate innovative and research capability. Demonstration of this capability shall be by evidence of publication of research papers or reports, or development of innovative processes or products, or the award of patents.

Skill Level 1 – Master’s degree in an engineering or science field directly related to the task to be performed plus eight (8) years of experience.

Skill Level 2 – Master’s degree in an engineering or science field directly related to the task to be performed plus five (5) years of experience.

Skill Level 3 – Master’s degree in an engineering or science field directly related to the task to be performed plus four (4) years of experience.



Incidental Labor Category Descriptions

TECHNICAL ASSISTANT

Duties: Performs support duties directly related to engineering and technical support. May work independently or under direct supervision. Specific duties may include but are not limited to program/project administration, resource allocation accounting and reporting, documentation planning, preparation and editing, inventory management and/or maintenance, word processing, filing, data entry, general office administrative duties and secretarial support. Position may require close liaison with manager and/or supervisor and frequent interfacing with customers at all levels.

Qualifications: Training and/or experience in support area provided, including, but not limited to business administration, accounting, bookkeeping, inventory management, technical writing, drafting, technical graphics, test and evaluation, security administration, and general office skills such as the ability to use office equipment, standard word processing and spreadsheet software, calculators, automated data processing systems, typewriters, etc.

Skill Level 1 – Bachelor’s Degree in discipline related to support provided plus five (5) years related experience; or Associates Degree in discipline related to support provided plus eight (8) years related experience; or High School Diploma (or equivalent) plus fifteen (15) years of related experience.

Skill Level 2 – Bachelor’s Degree in discipline related to support provided; or Associates Degree in discipline related to support provided plus five (5) years related experience or High School Diploma (or equivalent) plus eight (8) years related experience.

Skill Level 3 – Associates Degree in discipline related to support provided; or High School Diploma (or equivalent) plus three (3) years related experience.

Skill Level 4 – High School Diploma (or equivalent).

TECHNICAL ILLUSTRATOR /MULTIMEDIA SPECIALIST

Duties: Produces visual solutions to communicate complex technical and operational concepts using a mix of creative skills and visual design expertise. Directly supports program objectives through the use of visual illustrations and multimedia support.



Qualifications: Personnel will have four or more years of experience in a wide range of multimedia support to include computer-aided design. A degree in Graphic Arts, Graphic Design, Studio Art, Digital Media, Computer Aided Design or a related discipline is a plus.

Skill Level 1 – Master’s degree in related discipline plus four (4) years of related experience, or Bachelor’s degree in related discipline plus eight (8) years of related experience, or High School diploma or equivalent plus fifteen (15) years of-related experience.

Skill Level 2 – Master’s degree in related discipline, or Bachelor’s degree in related discipline plus four (4) years of related experience, or High School diploma or equivalent plus eight (8) years of related experience.

Skill Level 3 – Bachelor’s degree in related discipline, or High School diploma/equivalent plus four (4) years of related experience.

LOGISTICS ANALYST

Duties: Provides logistics support in the areas of engineering, supply, configuration management, technical requirements identification, and installation. May include maintenance of equipment, safety, and documentation development. Analyzes data to determine mission requirements and geographic needs. Provides detailed reports. Analyzes and evaluates design concepts and integration support requirements. Administers automated logistics systems and may be required to work with computer system users and programmers to design, develop and implement new processes.

Qualifications: Personnel must have experience performing logistics functions. Bachelor’s degree in computer science, engineering or science field will substitute for four (4) years of experience. High School diploma or equivalent is required.

Skill Level 1 – Twenty-six years of experience is required.

Skill Level 2 – Twenty-two years of experience is required.

Skill Level 3 – Eighteen years of experience is required.

Skill Level 4 – Fourteen years of experience is required.

Skill Level 5 – Twelve years of experience is required.

Skill Level 6 – Ten years of experience is required.

Skill Level 7 – Eight years of experience is required.



Skill Level 8 – Six years of experience is required.

Skill Level 9 – Four years of experience is required.

Skill Level 10 – Associates Degree (or equivalent) is required.

MANAGER

Duties: Directs the performance of a variety of related projects which may be organized by technology, program or client. Oversees the technology development and/or application, marketing, and resource allocation within program client base. Responsible for formulating and enforcing work standards, assigning task schedules, and reviewing work discrepancies. Manages personnel, communicates policies, purposes, and goals of the organization to subordinates. Responsible for management of project or task and assigned staff.

Qualifications: Personnel must have experience performing in a supervisory role. Bachelor's degree in Business Administration or Management will substitute for, four (4) years of experience. A High School diploma or equivalent is required.

Skill Level 1 – Twenty-four years of experience is required.

Skill Level 2 – Twenty years of experience is required.

Skill Level 3 – Sixteen years of experience is required.

Skill Level 4 – Twelve years of experience is required.

Skill Level 5 – Eight years of experience is required.
